## **ACTnow's Note**

On 11 March 2021, a report was made to ACTnow regarding a questionable Covid's SOP in SJKC(c) Connaught 2 in Bandar Damai Perdana Cheras, Selangor. Parents were seen gathering outside of the school after school hours without any SOP and this deeply concerns the reporter as it may create a new cluster. ACTnow has contacted the Headmistress of the said school and volunteered to assist in arranging and implementing the SOP, however it was rejected. Recently, the reporter updated ACTnow that there have been positive cases detected in this school.





Similar situation happened in SJK(C) Puay Chai 2, Bandar Utama when six students were tested positive and 11 teachers were home-quarantined. Parents are unsure if it is safe to send students to school due to weak SOP practises as there was no transparency nor written black-and-white stating the procedures to be taken to ensure safety. Parents, too, were not told what to do if their children's classmates were tested positive.

The headmistress, Soh Swee Koon was commended by the school's parent-teacher association chairman for applying a school closure to the Health Ministry, however it was

rejected as the government did not consider it to be a Covid-19 cluster. However, on April 13, the district education office took action by ordering the school to immediately close down and move all classes online. ACTnow does not wish the same fate happening to other schools as it is a crowded place from all sorts of places. SOPs are extremely important to manage the crowd of pupils and parents waiting before and after school. Otherwise, it will create a cluster which undoubt-

edly will spread to the entire area instantly. Most importantly, children and elderly at




